# STARS to Quality

The Best Beginnings STARS to Quality Program (STARS) is about continuous quality improvement, not only at the program level, but at the state level for the STARS program as a whole. STARS will be seeing changes to the framework in the coming months due to input gathered from stakeholders in a variety of ways. A STARS evaluation was conducted with the QRIS National Learning Network with the BUILD Initiative in September of 2019. The evaluation provided Montana with valuable information, including identified areas of strength, challenges, QRIS strategies from other states, goals for Montana, and next steps. In October, many STARS providers attended the STARS Institute. During the Institute, time was dedicated to receiving feedback from STARS programs and partners. ### **CCR&R Structure**

#### **CCR&R Network Director**

The Montana Child Care Resource and Referral Network (MCCRRN) is excited to introduce Meghan Hollifield Ballenger as the Network Director. Meghan has been in her new position since May 2019. Meghan, along with her husband and their dog, Moose, moved to Montana in July 2018. With a decade of non-profit experience, Meghan was previously at CASA of Missoula and prior to that has worked in family visitation and therapeutic foster care. MCCRRN is expanding its focus to support regional Child Care Resource and Referral organizations. Since Meghan's arrival, MCCRRN has initiated and supported regional learning communities across the state and hosted a Home-base Child Care conference. Next steps for the Network include launching a statewide consumer education campaign and coordinating shared services for providers. The mission of the Montana Child Care Resource and Referral Network is to unite Montana's Child Care Resource and Referral Agencies and coordinate their efforts so that they may leverage their resources to their fullest capacity and make quality child care accessible to all of Montana's families.

#### **CCR&R New Positions**

ECSB is funding two new positions within CCR&R agencies: a Family Engagement Coordinator and an Outreach and Communications Specialist.

Family Engagement Coordinator will support both Family Services Staff and Provider Services Staff to meet the unique needs of families served by regional CCR&R Agencies.

The Family Engagement position will be responsible for services, such as but not limited to, the following:

- Parent Education
- Special Needs
- Services for the Homeless
- Vulnerable populations
- Referrals
- Transition and advocacy
- Collaboration with the Early Childhood Community Coalitions
- Collaboration with Child and Family Services

The Outreach and Communications Specialist has a focus on services that support promotion or collaboration of services for Early Care and Education providers. The Outreach Specialist position will be responsible for services, such as but not limited to, the following:

- Consumer education
- Media/marketing

- Community support and engagement
- Emergency Planning

# Strengthening Montana's Early Childhood System Project

The Montana Department of Public Health and Human Services launched the Strengthening Montana's Early Childhood System Project in 2019 through a Preschool Development Birth through Five (PDG B-5) grant from the Administration for Children and Families. The Strengthening Montana's Early Childhood System Project is focused on developing the state's comprehensive early childhood system to enhance early learning and development, family support and engagement, and health to move the state toward its vision of all children having the skills and knowledge they need to reach their full potential in life.

Montana submitted an application for the Preschool Development Birth through Five Renewal Grant in November 2019. The Strengthening Montana's Early Childhood System project renewal grant will help the state further achieve early childhood system goals based on achievements and lessons learned from the 2019 planning grant year. Work within the renewal grant is aligned with the early childhood needs assessment findings and strategic plan goals. We expect to achieve the following outcomes, aligned with the state's early childhood strategic plan, through the PDG B-5 renewal grant project:

- 1. Montana's families with young children have increased access to, and participation in high quality early care and education across a mixed delivery system.
- 2. Montana's early childhood workforce is confident and effective, due to enhanced ECE professional development.
- 3. The early childhood system is coordinated to support effective family assessment, system navigation, care coordination, and use of data.
- 4. Montana's families are engaged and valued as partners in the early childhood system.
- 5. Montana's communities make early childhood a priority, and act to support children's health, learning, and well-being.
- 6. Montana's early childhood system is structured to support policy alignment, strategic financing, continuous improvement, and accountability.
